# **Ste. Genevieve's Vertical Log Treasures**

How many vertical log structures still stand in Ste. Genevieve? Our town is famous for its vertical log buildings. Some are nationally recognized, some have been officially registered, but many are private secrets. Many visitors to Ste. Genevieve might leave with the impression that there are only about half a dozen such buildings here. Even local residents may be surprised to learn that seemingly normal white siding may disguise vertical log buildings. The Ste. Genevieve Welcome Center has started an informal list of the widely recognized vertical structures located within the boundary of the National Historic Landmark District.

Ste. Genevieve holds the distinction of the having the largest concentration of French Colonial buildings in North America. The French settlers who migrated here originated from the Quebec area and before that from the Normandy region of France. In those locations, homes were typically built with vertical logs and very steeply pitched roofs supported by Norman trusses. Here in Ste. Genevieve and in French settlements further south, galleries were added to shade the buildings and protect the white-washed or plastered exterior walls resulting in the distinctive hipped, colonial roof as seen on the Bolduc House, the Jean Baptiste Valle House, the Bequette Ribault house, and others.

While many buildings in early Ste. Genevieve were constructed with their heavy timbers installed vertically on a sill, others were built with the vertical logs placed directly in the ground. Three out of the five known remaining poteaux-en-terre (post-in-ground) buildings in the United States are located on St. Marys Road/Main Street. They are the Bequette-Ribault House, the Bauvais-Amoureux House, and the Vital St. Gemme Beauvais House, all constructed between 1792 and 1808.

Of the vertical log structures still standing, so far the earliest date of construction verified through dendrochronology, tree ring dating, is that of the Green Tree Tavern. Also known as the Janis-Ziegler Home, it was built in 1790. Construction using vertical timbers continued in Ste. Genevieve perhaps as late as the mid-1800s.

# Winter Water Tips

## Well folks, it's here!

Winter that is. If you have not already made preparations for the cold, you better get to it. Here are a few tips to help you out.

### Winter Water Tips

It is a good idea to know where your main-line valve (to shut off your water) is located and check it for proper operation. This valve controls water flowing into your home and is usually found near where the water line comes into your house. Knowing where the valve is will allow you to quickly turn off the water if a pipe should burst or you have other water problems.



Eliminate drafts. Check around the home for areas where water supply lines are located in unheated areas and take measures to prevent the flow of cold air in these areas. Look under the house, in the basement, crawl space, attic, garage, and under kitchen and bathroom cabinets. Both hot and cold water pipes in these areas could freeze and should be insulated. Insulation supplies are available at your local home improvement or hardware store.



If your water pipes do freeze, never try to thaw a pipe with an open flame or torch. Always be careful of the potential for electric shock if an electric appliance is used around water.



# What if I lose the heat source in my home?

If you are staying in your home, or will be monitoring your home frequently, allow a faucet to drip cold water slowly. At a minimum, the dripping faucet should be the one that is the greatest distance from your main water shutoff valve. Also, consider allowing a slow drip in areas that are least protected from the cold, such as basements, crawl spaces, attics, the garage.

### What do I do if my water meter freezes?

If you suspect you have a frozen water meter, call us for help. Do not attempt to thaw the water meter yourself as this can result in extensive damage. Contact Ste. Genevieve City Hall during normal business hours (8am-5pm) @ 573-883-5400 or after hours @ 573-880-1175 in case of an emergency.
